WHEREAS, the Provincial Government of Isabela upholds a policy on the effective, efficient, and prudent utilization of government funds and resources to ensure that its people receive appropriate services that are responsive to their needs and promotive of their welfare;

WHEREAS, the Provincial Government of Isabela (PGI) has identified remaining funds from seven previously authorized projects under the 20% Development Fund in its Annual Budgets from the years 2018 to 2024, totaling **Two Hundred Twenty-Six Million Six Hundred Twenty-Three Thousand Pesos (P226,623,000.00)**;

WHEREAS, these funds have been identified by the Office of the Governor to be available for reprogramming, and was proposed to be reprogrammed towards two critical initiatives: the **Repair/Improvement of Queen Isabella Park** and the **Procurement of Palay and Rice Subsidy Program**, which will respectively enhance local heritage and recreational infrastructure and address food security and agricultural stability in the province;

WHEREAS, presented to this August Body is the proposed Supplemental Annual Investment Program of the Provincial Government of Isabela for Fiscal Year 2024 covering the funds mentioned in the previous clause amounting to Php226,623,000.00;

WHEREAS, as proposed in the said Supplemental Annual Investment Plan, the funds shall be utilized as follows:
