A RESOLUTION DECLARING ORDINANCE NO. 2024-1401 (SUPPLEMENTAL BUDGET NO. 04 FY 2024) IN THE AMOUNT OF THIRTY TWO MILLION FOUR HUNDRED TWELVE THOUSAND FOUR HUNDRED ONE PESOS & 12/100 (P32,412,401.12) OF THE MUNICIPALITY OF SAN MARIANO, ISABELA OPERATIVE IN ITS ENTIRETY SUBJECT TO SOME CONDITIONS

WHEREAS, Ordinance No. 2024-1401, an Ordinance authorizing Supplemental Budget No. 04 for CY 2024 of the Municipality of San Mariano, Isabela in the amount of THIRTY TWO MILLION FOUR HUNDRED TWELVE THOUSAND FOUR HUNDRED ONE PESOS & 12/100 (P32,412,401.12) out of the unappropriated ending balance of Supplemental Budget No. 03 embodied in Ordinance No. 2024-1386 of the Local Government of San Mariano, Isabela, was submitted to this Sanggunian for review pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the subject Ordinance complies with the budgetary requirements, general limitations and other pertinent provisions set forth under Republic Act No. 7160;

A RESOLUTION DECLARING ORDINANCE NO. 2024-1401 (SUPPLEMENTAL BUDGET NO. 04 FY 2024) IN THE AMOUNT OF THIRTY TWO MILLION FOUR HUNDRED TWELVE THOUSAND FOUR HUNDRED ONE PESOS & 12/100 (P32,412,401.12) OF THE MUNICIPALITY OF SAN MARIANO, ISABELA OPERATIVE IN ITS ENTIRETY SUBJECT TO SOME CONDITIONS

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 2024-1401 of the Municipality of San Mariano, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of R.A No. 7160, and further subject to some conditions:

- 1. The payment of Monetization of Leave Credits in the amount of Eight Hundred Forty Six Thousand Twenty Eight Pesos & 12/100 (P846,028.12), shall be in accordance with DBM Budget Circular No. 2016-2 dated March 29, 2016, on the Computation and Funding of Terminal Leave Benefits and Monetization of Leave Credits, and CSC Memorandum Circular No. 02, s. 2016, on the Amendment to the Constant Factor in the Formula used for Computing Terminal Leave Benefits (Section 40) and Computation of Leave Monetization (Section 24) of the Omnibus Rules on Leave;
- 2. All procurement activities must be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its Implementing Rules and Regulations. Further, the acquisition of Motor Vehicles in the amount of Six Million Six Hundred Thousand Pesos (P6,600,000.00) shall be subject to the provisions of Budget Circular No. 2022-1 dated February 11, 2022, the Omnibus Guidelines on the Acquisition, Use, Rental and Replacement of Government Motor Vehicles;

RESOLVED FURTHER, to inform the Municipality of San Mariano, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

RESOLVED FINALLY, to furnish a copy of this Resolution to the **Honorable EDGAR TALOSIG GO**, Municipal Mayor, and to the Sangguniang Bayan of the Municipality of San Mariano, Isabela through the **Honorable DEAN ANTHONY G. DOMALANTA**, Municipal Vice-Mayor.
