### **RESOLUTION NO. 2024-42-02** Series of 2024

**A RESOLUTION DECLARING ORDINANCE NO. 2024-386 OF THE MUNICIPAL LOCAL GOVERNMENT UNIT OF QUEZON, ISABELA AS INTRA VIRES**

**WHEREAS**, pursuant to Article 468(a)(i) of the Local Government Code, the Sangguniang Panlalawigan has the authority to “review all ordinances approved by the Sanggunian of component cities and municipalities” and to “determine whether these are within the scope of the prescribed powers of the Sanggunian”;

**WHEREAS**, presented before this Honorable Body is Ordinance No. 2024-386 of the Municipal Local Government Unit of Quezon, Isabela (MLGU Quezon) entitled, “**AN ORDINANCE AUTHORIZING THE BORROWING OF THE MUNICIPALITY OF QUEZON FROM THE LAND BANK OF THE PHILIPPINES FOR A TERM IN THE AMOUNT OF NINETY MILLION PESOS (P90,000,000.00), AND HEREBY AUTHORIZING THE HONORABLE JIMMY S. GAMAZON, JR., MUNICIPAL MAYOR, TO ENTER INTO THE LOAN AGREEMENT WITH THE SAID BANK AND TO SIGN OTHER DOCUMENTS NEEDED FOR THIS PURPOSE**”;

**WHEREAS**, as stated in the Ordinance, MLGU Quezon will enter into a Loan Agreement with the Land Bank of the Philippines for the amount of Ninety Million Pesos (P90,000,000.00) *to be utilized for the Construction of New Quezon Public Market, Purchase of the Cemetery Lot and Purchase of School Lot*;

**A RESOLUTION DECLARING ORDINANCE NO. 2024-386 OF THE MUNICIPAL LOCAL GOVERNMENT UNIT OF QUEZON, ISABELA AS INTRA VIRES**

**WHEREAS**, Section 297 (a) of the Local Government Code allows local government units to contract loans, credits, and other forms of indebtedness with any government or domestic private bank and other lending institutions to finance the construction, installation, improvement, expansion, operation, or maintenance of public facilities, infrastructure facilities, housing projects, the acquisition of real property, and the implementation of other capital investment projects, subject to such terms and conditions as may be agreed upon by the local government unit and the lender;

**WHEREAS**, this Honorable Body recognizes that local government units possess direct information concerning the needs of their citizens and the conditions within their jurisdiction and thus have the appropriate standing and capacity to identify the programs, projects, and activities that will further the welfare of their people;

**WHEREAS**, after careful review and with due consideration to the recommendation of the Provincial Budget Office interposing no objection and stating no adverse finding to Ordinance No. 2024-386 of the MLGU Quezon, this Honorable Body finds that the said ordinance is a valid exercise of the legislative powers of their Sanggunian and within the authority of MLGU Quezon, as prescribed by law subject to compliance with the budgetary limitations for debt servicing as provided in Section 324 of the Local Government Code;

**WHEREFORE**, upon motion of the Honorable Delfinito Emmanuel L. Albano, duly approved and seconded in a session duly assembled, it was –

**RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION DECLARING ORDINANCE NO. 2024-386 OF THE MUNICIPAL LOCAL GOVERNMENT UNIT OF QUEZON, ISABELA AS INTRA VIRES.**
