**A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 03 S. 2024 (SUPPLEMENTAL BUDGET NO. 03 FY 2024) IN THE AMOUNT OF ONE MILLION THREE HUNDRED FORTY TWO THOUSAND EIGHT HUNDRED NINETY FIVE PESOS & 95/100 (P1,342,895.95) OF THE MUNICIPALITY OF MALLIG, ISABELA OPERATIVE IN ITS ENTIRETY SUBJECT TO CONDITIONS**

**WHEREAS**, Appropriation Ordinance No. 03 Series 2024, an Ordinance authorizing Supplemental Budget No. 03 Calendar Year 2024 involving an amount of **ONE MILLION THREE HUNDRED FORTY TWO THOUSAND EIGHT HUNDRED NINETY FIVE PESOS & 95/100 (P1,342,895.95)** derived from savings of vacant positions for the creation of new positions and for the increase of RATA and Clothing Allowance of qualified officials and employees of the Municipal Government of Mallig, Isabela, was submitted to this Sanggunian for review, pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the subject Ordinance complies with the budgetary requirements, general limitations and other pertinent provisions set forth under Republic Act No. 7160;

**NOW THEREFORE**, on motion of **SP Member DELFINITO EMMANUEL L. ALBANO** duly seconded:

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

**RESOLVED**, to declare Appropriation Ordinance No. 03 S. 2024 of the Municipality of Mallig, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of Republic Act No. 7160 and subject further to the following conditions:

1. The grant of Clothing Allowance shall be in accordance with DBM Budget Circular No. 2024-1 dated April 4, 2024;
2. The utilization of the appropriation for Representation Allowance and Transportation Allowance shall be in accordance with DBM Local Budget Circular No. 157 dated May 3, 2024;
3. The creation of positions shall be consistent with the rules and regulations as prescribed under CSC Memorandum Circular No. 12, series of 2022. Further, creation of non-mandatory positions and offices in LGUs may be allowed subject to the following conditions:
  - a. That they are priority needs as identified by the LCE, the Sanggunian and/or LDCs concerned consistent with Section 17 of RA No. 7160;
  - b. All mandatory positions stipulated under RA No. 7160 and other pertinent laws have been created and provided;
  - c. The SSL has been fully implemented; and
  - d. The general limitations on PS expenditures are not exceeded;

**RESOLVED FURTHER**, to require the Municipality of Mallig, Isabela to comply with the herein conditions.

**RESOLVED FURTHERMORE**, to inform the Municipality of Mallig, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

**RESOLVED FINALLY**, to furnish a copy of this Resolution to the **Honorable JOSE PHILIP F. CALDERON**, Municipal Mayor, and to the Sangguniang Bayan of the Municipality of Mallig, Isabela through the **Honorable DEO ANGELO ELEFANTE**, Municipal Vice-Mayor.
