A RESOLUTION DECLARING ORDINANCE NO. 11-2024 OF THE MUNICIPAL LOCAL GOVERNMENT UNIT OF RAMON, ISABELA AS VALID

WHEREAS, pursuant to Article 468(a)(i) of the Local Government Code, the Sangguniang Panlalawigan has the authority to “review all ordinances approved by the sanggunian of component cities and municipalities” and to “determine whether these are within the scope of the prescribed powers of the Sanggunian”;

WHEREAS, presented before this Honorable Body is Ordinance No. 11-2024 of the Municipal Local Government Unit of Ramon, Isabela (MLGU Ramon) entitled, “**AN ORDINANCE REPROGRAMMING A PORTION OF THE SIXTY-EIGHT MILLION EIGHTY-FIVE THOUSAND TWO HUNDRED PESOS (PHP. 68,085,200.00) LOAN PROCEEDS FROM LAND BANK OF THE PHILIPPINES (LBP), SOUTHERN ISABELA LENDING CENTER, CAUAYAN CITY (ISABELA) AMOUNTING TO TWENTY-NINE MILLION PESOS (PHP 29,000,000.00) FOR A REGULAR PROJECT OF REHABILITATING AND UPGRADING A FARM-TO-MRKET (FMR) LOCATED AT BURGOS, RAMON, ISABELA, WHICH IN EFFECT AMENDING SECTION 2 OF MUNICIPAL ORDINANCE NO. 05-2024 OF THE MUNICIPALITY OF RAMON, ISABELA**”;

A RESOLUTION DECLARING ORDINANCE NO. 11-2024 OF THE MUNICIPAL LOCAL GOVERNMENT UNIT OF RAMON, ISABELA AS INTRA VIRES

WHEREAS, as stated in the Ordinance, MLGU Ramon will reprogram the amount of Twenty-Nine Million Pesos (P29,000,000.00) from the proceeds of their Loan Agreement with the Land Bank of the Philippines in the amount of Sixty-Eight Million Eighty-Five Thousand Two Hundred Pesos (P68,085,200.00) *to be utilized for the Rehabilitation and Upgrading of Burgos Farm-to-Market Road for the MLGU Ramon;*

WHEREAS, this Honorable Body recognizes that local government units possess direct information concerning the needs of their citizens and the conditions within their jurisdiction and thus have the appropriate standing and capacity to identify the programs, projects, and activities that will further the welfare of their people;

WHEREAS, after careful review and with due consideration to the recommendation of the Provincial Budget Office interposing no objection and stating no adverse finding to Ordinance No. 11-2024 of the MLGU Ramon, this Honorable Body finds that the said ordinance is a valid exercise of the legislative powers of their Sanggunian and within the authority of MLGU Ramon, as prescribed by law subject to compliance with the budgetary limitations for debt servicing as provided in Section 324 of the Local Government Code;

WHEREFORE, upon motion of the Honorable Delfinito Emmanuel L. Albano, duly approved and seconded in a session duly assembled, it was –

RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION DECLARING ORDINANCE NO. 11-2024 OF THE MUNICIPAL LOCAL GOVERNMENT UNIT OF RAMON, ISABELA AS INTRA VIRES.
