WHEREAS, Appropriation Ordinance No. 2024-007, an ordinance approving Supplemental Budget No. 05, Calendar Year 2024, of the Local Government Unit of Echague, Isabela, appropriating the amount of FIVE MILLION EIGHT HUNDRED SEVEN THOUSAND FIVE HUNDRED PESOS & 08/100 (P5,807,500.08) derived from PS savings for the funding of various newly created and existing positions, and additional fund for MOOE of the Municipal Mayor's Office, Municipality of Echague, Isabela, was submitted to this Sanggunian for review pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

NOW THEREFORE, on motion of **SP Member DELFINITO EMMANUEL L. ALBANO** duly seconded:

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 2024-007 (2024 Supplemental Budget No. 05) of the Municipality of Echague, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of Republic Act No. 7160 and subject further to the following conditions:

- 1. The creation of positions shall be consistent with the rules and regulations as prescribed under CSC Memorandum Circular No. 12, series of 2022. Further, creation of non-mandatory positions and offices in LGUs may be allowed subject to the following conditions:
 - a. That they are priority needs as identified by the LCE, the Sanggunian and/or LDCs concerned consistent with Section 17 of RA No. 7160;
 - b. All mandatory positions stipulated under RA No. 7160 and other pertinent laws have been created and provided;
 - c. The SSL has been fully implemented; and
 - d. The general limitations on PS expenditures are not exceeded.
- 2. The grant of Year-End Bonus and Cash Gift shall be in accordance with DBM Budget Circular No. 2016-4 dated April 28, 2016;
- 3. That all procurement activities shall be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its 2016 Revised Implementing Rules and Regulations.

RESOLVED FURTHER, to require the Municipality of Echague, Isabela to comply with the herein review findings and/or conditions and notify this body of actions taken thereon.

RESOLVED FURTHERMORE, to inform the Municipality of Echague, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

RESOLVED FINALLY, to furnish a copy of this Resolution to the **Honorable FRANCIS FAUSTINO A. DY**, Municipal Mayor, and to the Sangguniang Bayan of the Municipality of Echague, Isabela through the **Honorable ALLAN P. TUPONG**, Municipal Vice-Mayor.
