WHEREAS, the Provincial Government of Isabela (PGI) adheres to and supports the rules and regulations set forth by the Commission on Elections (COMELEC);

WHEREAS, Article IX (C) Section 2 of the 1987 Constitution mandates the COMELEC to enforce and administer laws and regulations relative to the conduct of elections, plebiscites, initiatives, referendums and recalls, particularly in the upcoming National and Local Elections, and Bangsamoro Autonomous Region in Muslim Mindanao (BARMM) Parliamentary Elections;

WHEREAS, the COMELEC issued Resolution No. 11060 prescribing for the rules and regulations on the prohibition against the release, disbursement, or expenditure of public funds for social services and housing-related projects, and issuance of treasury warrants

and similar devices under sections 261 (v) and (w) of the omnibus election code in connection with the May 12, 2025 national and local elections, and BARMM parliamentary elections:

WHEREAS, the said resolution prohibits the release, disbursement, or expenditure of public funds for social welfare and services starting March 28, 2025, for a period of 45 days, to ensure impartiality and avoid undue influence during the elections;

WHEREAS, the PGI is currently implementing significant programs, projects, and activities (PPAs) in the province, particularly in health and social welfare assistance, and seeks to ensure the continuity of these services during the election period;

WHEREAS, the Provincial Government of Isabela intends to seek an exemption from the prohibition to ensure the uninterrupted implementation of its regular and long-established PPAs, including but not limited to the following:

- 1. Bojie-Rodito Opportunities (BRO) Scholarship Program
- 2. BRO LUSOG (Laban sa Undernutrition, sa Sakit, Obesity at Gutom) Feeding Program
- 3. Isabela Recovery Initiatives to Support Enterprise (I-RISE)
- 4. Grants, donations and subsidies of the Office of the Governor
- 5. Tobacco Excise Tax Distribution as a subsidy to tobacco farmers, livelihood assistance, and financial assistance to tobacco farmers;

WHEREAS, the Provincial Government of Isabela (PGI) upholds the rules and regulations of the Commission on Elections (COMELEC) while prioritizing the uninterrupted delivery of vital social services, particularly to the underprivileged, during the election period;

WHEREAS, the PGI seeks to file a request for exemption from COMELEC's prohibitions to ensure continuous access to healthcare and other essential services for every Isabeleño, safeguarding critical programs from disruption during the election period;

WHEREAS, under Section 465 (b) (vi) of R. A. No. 7160, the Governor is empowered to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, premises considered, upon motion of Honorable Maria Katrina Jessica G. Dy, duly approved and seconded in a session duly assembled, it was —
