WHEREAS, the Sangguniang Panlalawigan recognizes that the execution of the Deed of Absolute Sale and other necessary documents is essential to ensure the successful completion of the transaction and acquisition of the said properties for the benefit of the Provincial Government of Isabela;

WHEREAS, the acquisition of these properties is advantageous to the province as it will provide additional assets for income-generating ventures, agricultural development programs, and other priority initiatives that will contribute to the economic growth and social welfare of the province;

WHEREAS, Section 465, par. (b)(1)(vi) of the Local Government Code of 1991 empowers the Provincial Governor to represent the Province in all its business transactions and sign on its behalf all contracts and other documents upon the authority of the Sangguniang Panlalawigan;
