A RESOLUTION DECLARING APPROPRIATION ORDINANCE NO. 451 S. 2024 (2025 ANNUAL BUDGET) IN THE TOTAL AMOUNT OF THREE HUNDRED THIRTY NINE MILLION FIVE HUNDRED SEVENTEEN THOUSAND FOUR HUNDRED TWENTY FOUR PESOS & 66/100 (P339,517,424.66) OF THE MUNICIPALITY OF DINAPIGUE, ISABELA OPERATIVE IN ITS ENTIRETY SUBJECT TO CONDITIONS

WHEREAS, Appropriation Ordinance No. 451 S. 2024, an Ordinance authorizing the Annual Budget of the Local Government of Dinapigue, Isabela for Fiscal Year 2025 in the total amount of **THREE HUNDRED THIRTY NINE MILLION FIVE HUNDRED SEVENTEEN THOUSAND FOUR HUNDRED TWENTY FOUR PESOS & 66/100 (P339,517,424.66)** covering the various expenditures for the operation of the Municipal Government of Dinapigue, Isabela and appropriating the necessary funds for the purpose pursuant to the provision of Section 327 of Republic Act 7160, otherwise known as the Local Government Code of 1991.

WHEREAS, the subject Ordinance shows substantial compliance with the budgetary requirements, general limitations and other pertinent provisions set forth under Republic Act No. 7160.

NOW THEREFORE, on motion of **SP Member DELFINITO EMMANUEL L. ALBANO** duly seconded:

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare the Appropriation Ordinance No. 451 S. 2024 (2025 Annual Budget) of the Municipality of Dinapigue, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of R.A No. 7160 and subject further to the following conditions:

1. That the grant of Medical Allowance shall be in accordance with the guidelines, rules, and regulations provided under DBM Local Budget Circular No. 2024-6 dated December 12, 2024;
2. The appropriation for Donations shall be solely spent for public purposes pursuant to Sections 305 (b), 335 and 351 of the LGC;
3. That one percent (1%) of the NTA of the municipality shall be allocated for the strengthening and implementation of the programs of the Local Council for the Protection of Children pursuant to Section 15 of RA No. 9344;
4. The utilization of 5% Local Disaster Risk Reduction and Management Fund (LDRRMF) and the special trust fund from the unused/unexpended balance in prior year's LDRRMF shall be in accordance with the approved LDRRM Plan and NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 as reviewed by the Office of the Civil Defense (OCD) pursuant to RA No. 10121. A copy of the OCD-reviewed LDRRMF shall be provided to this Office;
5. That the appropriation for the 20% Development Fund shall be subject to the pertinent provisions of DBM-DOF-DILG Joint Memorandum Circular No. 1, s. 2020 dated November 4, 2020;
6. That all procurement activities must be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its 2016 revised Implementing Rules and Regulations. Further, the acquisition of Motor Vehicles shall be subject to the provisions of Administrative Order No. 14 dated December 10, 2018 and Budget Circular (BC) No. 2022-1 dated February 11, 2022;
7. That the provisions for programs and projects shall be consistent with the approved Annual Investment Program (AIP) of the Municipality prepared in accordance with DILG-NEDA-DBM-DOF JMC No. 1, s. 2016 dated November 18, 2016.

RESOLVED FURTHER, to require the Municipality of Dinapigue, Isabela to comply with the herein conditions and notify this body of actions taken thereon.
