THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 2024-23 of the Municipality of San Agustin, Isabela OPERATIVE IN ITS ENTIRETY subject to the posting requirements under Section 59 of Republic Act No. 7160, and subject further to the following conditions:

- 1. The appropriation for the grant of Service Recognition Incentive (SRI) in the amount of Two Million Two Hundred Thousand Pesos (P2,200,000.00) shall be in accordance with AO No. 27 dated December 12, 2024 and DBM Budget Circular No. 2024-7, dated December 16, 2024;
- 2. The utilization of Terminal Leave Benefits and Monetization of Leave Credits shall be in accordance with CSC Omnibus Rules on Leave pursuant to CSC MC No. 41 s. 1998, BC 2013-1 dated April 12, 2013, BC No. 2016-2 dated March 29, 2016;
- 3. The appropriation for Donations shall be solely spent for public purposes pursuant to Sections 305 (b), 335 and 351 of the LGC;
- 4. That all procurement activities must be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its 2016 revised Implementing Rules and Regulations.

RESOLVED FURTHER, to require the Municipality of San Agustin, Isabela to comply with the herein review findings/conditions.

RESOLVED FURTHERMORE, to inform the Municipality of San Agustin, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

RESOLVED FINALLY, to furnish a copy of this Resolution to the Honorable CESAR A. MONDALA, Municipal Mayor, and to the Sangguniang Bayan of the Municipality of San Agustin, Isabela through the Honorable OLIVER D. MICU, Municipal Vice-Mayor.
