A RESOLUTION DECLARING ORDINANCE NO. 18, S-2023 (SUPPLEMENTAL BUDGET NO. 02 FY 2023) IN THE AMOUNT OF FORTY THREE MILLION PESOS (P43,000,000.00) OF THE MUNICIPALITY OF REINA MERCEDES, ISABELA OPERATIVE IN ITS ENTIRETY

WHEREAS, Ordinance No. 18, series 2023, an Ordinance authorizing Supplemental Budget No. 2 for FY 2023 of the Municipality of Reina Mercedes, Isabela involving the amount of **FORTY THREE MILLION PESOS (P43,000,000.00)** chargeable under the Landbank Loan of the Local Government of Reina Mercedes, Isabela, was submitted to this Sanggunian for review pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

A RESOLUTION DECLARING ORDINANCE NO. 18, S-2023 (SUPPLEMENTAL BUDGET NO. 02 FY 2023) IN THE AMOUNT OF FORTY THREE MILLION PESOS (P43,000,000.00) OF THE MUNICIPALITY OF REINA MERCEDES, ISABELA OPERATIVE IN ITS ENTIRETY

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 18, s-2023 of the Municipality of Reina Mercedes, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of R.A No. 7160, and subject further to the following conditions:

1. The said loan must be governed by Sec. 324 (b) of RA 7160, which states:

"That the amount of Appropriations for debt servicing shall not exceed twenty percent (20%) of the regular income of the LGU concerned."

2. All procurement activities must be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its Implementing Rules and Regulations.

RESOLVED FURTHER, to inform the Municipality of Reina Mercedes, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

RESOLVED FINALLY, to furnish a copy of this Resolution to the **Honorable MARIA LOURDES P. RESPICIO-SAGUBAN**, Municipal Mayor, and to the Sangguniang Bayan of the Municipality of Reina Mercedes, Isabela through the **Honorable ANTHONY P. RESPICIO**, Municipal Vice-Mayor.
