THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 06 S. 2024 of the Municipality of Mallig, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of Republic Act No. 7160 and subject further to the following conditions:

- That the Programs/Projects/Activities (PPAs) shall be in accordance with the program objectives of the Share of LGUs from the FY 2022 Collection of Burley and Native Tobacco Excise Taxes under RA No. 8240, as amended by RA No. 10351, and further amended by RA No. 11346 pursuant to Local Budget Memorandum (LBM) No. 91 dated August 29, 2024;
- 2. That all procurement activities must be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its 2016 revised Implementing Rules and Regulations.

RESOLVED FURTHER, to require the Municipality of Mallig, Isabela to comply with the herein conditions.

RESOLVED FURTHERMORE, to inform the Municipality of Mallig, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

RESOLVED FINALLY, to send a copy of this Resolution to the **Honorable JOSE PHILIP F. CALDERON**, Municipal Mayor, and to the Sangguniang Bayan of the Municipality of Mallig, Isabela through the **Honorable DEO ANGELO ELEFANTE**, Municipal Vice-Mayor.
