A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 19 S. 2024 (SUPPLEMENTAL BUDGET NO. 07 FY 2024) IN THE AMOUNT OF TWO MILLION PESOS (P2,000,000.00) OF THE MUNICIPALITY OF QUIRINO, ISABELA OPERATIVE IN ITS ENTIRETY SUBJECT TO SOME CONDITIONS

WHEREAS, Appropriation Ordinance No. 19 Series of 2024, an Ordinance authorizing Supplemental Budget No. 07 FY 2024 of the Local Government Unit of Quirino, Isabela amounting to **TWO MILLION PESOS (P2,000,000.00)** derived from Interest Income from Investment in Treasury Bills of the Municipality of Quirino, Isabela, was submitted to this Sanggunian for review, pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the subject Ordinance complies with the budgetary requirements, general limitations and other pertinent provisions set forth under Republic Act No. 7160;

A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 19 S. 2024 (SUPPLEMENTAL BUDGET NO. 07 FY 2024) IN THE AMOUNT OF TWO MILLION PESOS (P2,000,000.00) OF THE MUNICIPALITY OF QUIRINO, ISABELA OPERATIVE IN ITS ENTIRETY SUBJECT TO SOME CONDITIONS

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 19 S. 2024 of the Municipality of Quirino, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of Republic Act No. 7160 and subject further to the following conditions:

1. The utilization of 5% Local Disaster Risk Reduction and Management Fund (LDRRMF) shall be in accordance with the approved LDRRM Plan and NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 as reviewed by the Office of the Civil Defense (OCD) pursuant to RA No. 10121. A copy of the OCD-reviewed LDRRMF shall be provided to this Office;
2. The appropriation for Donations shall be solely spent for public purposes pursuant to Sections 305 (b), 335 and 351 of the LGC;
3. That all procurement activities must be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its 2016 revised Implementing Rules and Regulations.

RESOLVED FURTHER, to require the Municipality of Quirino, Isabela to comply with the herein review findings and/or conditions and notify this body of actions taken thereon.

RESOLVED FURTHERMORE, to inform the Municipality of Quirino Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

RESOLVED FINALLY, to furnish a copy of this Resolution to the **Honorable EDWARD D. JUAN**, Municipal Mayor, and to the Sangguniang Bayan of the Municipality of Quirino, Isabela through the **Honorable VICTOR EMMANUEL G. CALLANGAN**, Municipal Vice-Mayor.
