WHEREAS, Republic Act No. 11223, otherwise known as the "Universal Health Care" (UHC) Act has been enacted to provide all Filipinos access to a comprehensive set of quality, cost-effective, preventive, curative, rehabilitative and palliative health services without causing financial hardships and prioritizes the needs of the people who cannot afford such services;

WHEREAS, in response to the challenges brought about by the devolution of the delivery of health services and facilities of all Local Government Units (LGUs), Executive Order No. 138 and the 2018 Mandanas ruling fully reinforced the devolution of executive functions in LGUs and expand their share in the National Tax Allocation;

WHEREAS, by virtue of the Universal Health Care Act, the national government is mandated to provide financial and non-financial matching grants to improve the functionality of province-wide and city-wide health systems;

WHEREAS, the Provincial Government of Isabela (PGI) agreed to fund and implement the programs, projects and activities under its Local Investment Plan for Health (LIPH) / Annual Operational Plan through its own financing source, and through available funds and resources from the DOH, and development partners, coordinated with the DOH;

WHEREAS, a Terms of Partnership between the PGI and the Department of Health-Center for Health Development (DOH-CHD) has been proposed for the proper implementation and management of the Annual Operational Plan (AOP) for 2025. Thus, an authority for the execution of a Terms of Partnership is indispensable;

WHEREAS, under Section 465, (b) (vi) of R. A. No. 7160, the Provincial Governor is empowered to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, this Body deems it beneficial and advantageous for the Province to grant the Provincial Governor the necessary authority to sign the Terms of Partnership on behalf of the Provincial Government of Isabela;

WHEREAS, premises considered, upon motion of Honorable Emmanuel Joselito B. Añes, duly approved and seconded in a session duly assembled, it was -

RESOLVED, AS IT IS HEREBY RESOLVED, TO PASS A RESOLUTION AUTHORIZING THE HONORABLE GOVERNOR, RODOLFO T.
