WHEREAS, Appropriation Ordinance No. 25 Series of 2024, an Ordinance authorizing Supplemental Budget No. 10 for FY 2024 of the Local Government Unit of Quirino, Isabela involving an amount of **TWO MILLION FOUR HUNDRED TWENTY THOUSAND PESOS (P2,420,000.00)** derived from PS savings for the grant of Service Recognition Incentive (SRI) for FY 2024 to qualified officials and employees of the Municipal Government of Quirino, Isabela, was submitted to this Sanggunian for review, pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

THE SANGGUNIAN PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 30 S. 2024 of the Municipality of Quirino, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of Republic Act No. 7160 and subject further to the following conditions:

1. The appropriation for the grant of Service Recognition Incentive (SRI) in the amount of Two Million Four Hundred Twenty Thousand Pesos (P2,420,000.00) shall be in accordance with AO No. 27 dated December 12, 2024 and DBM Budget Circular No. 2024-7, dated December 16, 2024;

RESOLVED FURTHER, to require the Municipality of Quirino, Isabela to comply with the herein review findings and/or conditions and notify this body of actions taken thereon.

RESOLVED FURTHER, to inform the Municipality of Quirino, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

RESOLVED FINALLY, to furnish a copy of this Resolution to the **Honorable EDWARD D. JUAN**, Municipal Mayor, and to the Sangguniang Bayan of the Municipality of Quirino, Isabela through the **Honorable VICTOR EMMANUEL G. CALLANGAN**, Municipal Vice-Mayor.
