A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 2024-002 (SUPPLEMENTAL BUDGET NO. 01 CY 2024) IN THE AMOUNT OF SEVENTY THOUSAND FOUR HUNDRED FIFTEEN PESOS (P70,415.00) OF THE MUNICIPALITY OF ALICIA, ISABELA OPERATIVE IN ITS ENTIRETY

WHEREAS, Appropriation Ordinance No. 2024-002, an ordinance approving Supplemental Budget No. 01 for the Calendar Year 2024 of the Municipality Alicia, Isabela, amounting to **SEVENTY THOUSAND FOUR HUNDRED FIFTEEN PESOS (P70,415.00)** from the increase in National Tax Allotment for CY 2023 of the Local Government of Alicia, Isabela, was submitted to this Sanggunian for review, pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 2024-002 (Supplemental Budget No. 01 FY 2024) of the Municipality of Alicia, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of R.A No. 7160, and subject further to the following conditions:

1. That the appropriation for the 20% Development Fund shall strictly cover only the development projects prescribed and authorized under DBM-DOF-DILG Joint Memorandum Circular No. 1 dated November 4, 2020.

That the following appropriation under the 20% Development Fund shall be identified or broken-down into specific/project component indicating the activities/programs to be undertaken and the project site/location in accordance with DILG-NEDA-DBM and DOF JMC No. 1 Series of 2007:

1. Construction or rehabilitation of multi-purpose halls, including purchase of lot for the purpose for P14,083.00.
2. That all procurement activities shall be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its 2016 Revised Implementing Rules and Regulations;

RESOLVED FURTHER, to inform the Municipality of Alicia, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

RESOLVED FINALLY, to furnish a copy of this Resolution to the **Honorable JOEL AMOS P. ALEJANDRO**, Municipal Mayor, and to the Sangguniang Bayan of the Municipality of Alicia, Isabela through **Honorable ANDY BONN B. VELASCO**, Municipal Vice-Mayor.
