THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 003-2024 of the Municipality of Divilacan, Isabela OPERATIVE IN ITS ENTIRETY subject to the posting requirements under Section 59 of R.A No. 7160, and subject further to the following conditions:

1. The appropriation for the implementation of SSL VI Compensation Adjustment - 1st Tranche in the amount of One Million Six Hundred Twenty Six Thousand Two Hundred Thirteen Pesos & 95/100 (P1,626,213.95) must be in accordance with Executive Order No. 64 By the President of the Philippines dated August 2, 2024, on the Updating the Salary Schedule for Civilian Government Personnel and Authorizing the Grant of an Additional Allowance, and for Other Purposes, as supported by the guidelines of DBM Local Budget Circular No. 160, dated August 12, 2024, on the Implementation of the First Tranche of the Modified Salary Schedule for Local Government Personnel Pursuant to Executive Order (EO) No. 64, s. 2024;

RESOLVED FURTHER, to inform the Municipality of Divilacan, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

RESOLVED FINALLY, to furnish a copy of this Resolution to the **Honorable** VENTURITO C. BULAN, Municipal Mayor, and to the Sangguniang Bayan of the Municipality of Divilacan, Isabela through the Honorable ALFREDO P. CUSTODIO, Municipal Vice-Mayor.
