THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 455 S. 2024 of the Municipality of Dinapigue, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of R.A No. 7160, and subject further to the following conditions:

1. The appropriation for Donations shall be solely spent for public purposes pursuant to Sections 305 (b), 335 and 351 of the LGC. Further, the assistance to job order employees of the Local Government of Dinapigue, Isabela in the amount of Two Million Five Hundred Thousand Pesos (P2,500,000.00) shall be covered with appropriate guidelines and legal basis for its grant.

RESOLVED FURTHER, to inform the Municipality of Dinapigue, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

RESOLVED FINALLY, to furnish a copy of this Resolution to the , **Honorable ViCENTE D. MENDOZA**, Municipal Mayor, and to the Sangguniang Bayan of the Municipality of Dinapigue, Isabela through the **Honorable REYNALDO D. DERIJE**, Municipal Vice-Mayor.
