A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 2024-05 (SUPPLEMENTAL BUDGET NO. 05-2024) IN THE AMOUNT OF THIRTY SEVEN MILLION TWO HUNDRED NINETY SEVEN THOUSAND PESOS (P37,297,000.00) OF THE MUNICIPALITY OF QUEZON, ISABELA OPERATIVE IN ITS ENTIRETY SUBJECT TO SOME CONDITIONS

WHEREAS, Appropriation Ordinance No. 2024-05, an Ordinance authorizing the appropriation of Supplemental Budget No. 05-2024 in the amount of **THIRTY SEVEN MILLION TWO HUNDRED NINETY SEVEN THOUSAND PESOS (P37,297,000.00)** derived from New Revenue Source - Loan Proceeds to be allocated and utilized for the Construction of New Public Market and Acquisition of School and Cemetery Lot, was submitted to this Sanggunian for review pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the subject Appropriation Ordinance shows substantial compliance with the budgetary requirements and general limitations set forth under Republic Act No. 7160;

A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 2024-05 (SUPPLEMENTAL BUDGET NO. 05-2024) IN THE AMOUNT OF THIRTY SEVEN MILLION TWO HUNDRED NINETY SEVEN THOUSAND PESOS (P37,297,000.00) OF THE MUNICIPALITY OF QUEZON, ISABELA OPERATIVE IN ITS ENTIRETY SUBJECT TO SOME CONDITIONS

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 2024-05 (Supplemental Budget No. 5 FY 2024) of the Municipality of Quezon, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of R.A No. 7160, and subject further to the following conditions:

1. That the Thirty Seven Million Two Hundred Ninety Seven Thousand Pesos (P37,297,000.00) loan of the Municipality of Quezon, Isabela, must be governed by Sec. 324 (b) of RA 7160, which states:

"That the amount of Appropriations for debt servicing shall not exceed twenty percent (20%) of the regular income of the LGU concerned."

2. That all procurement activities shall be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its 2016 Revised Implementing Rules and Regulations.

RESOLVED FURTHER, to require the Municipality of Quezon, Isabela to comply with the herein conditions.

RESOLVED FURTHERMORE, to inform the Municipality of Quezon, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

RESOLVED FINALLY, to send a copy of this Resolution to the **Honorable JIMMY S. GAMAZON, JR.**, Municipal Mayor, and to the Sangguniang Bayan of the Municipality of Quezon, Isabela through the **Honorable DARYL G. GASCON**, Municipal Vice-Mayor.
