**WHEREAS**, the Provincial Government of Isabela (PGI), in pursuit of its mandate to provide accessible and quality healthcare services to its constituents, continuously seeks partnerships with organizations dedicated to medical and humanitarian missions;

**WHEREAS**, Smile Mission Ltd. (Smile Asia), an international non-profit organization dedicated to providing life-changing medical interventions, and the City Government of Ilagan, Isabel have expressed their willingness to collaborate with the Provincial Government of Isabela for the conduct of the International Friendship Medical Mission from March 16 to 25, 2025 in the City of Ilagan, Isabela;

**WHEREAS**, the International Friendship Medical Mission aims to provide comprehensive medical evaluation for one hundred (100) patients, with eighty (80) of them receiving free life-changing surgeries, particularly targeting individuals with cleft lip and cleft palate conditions;

**WHEREAS**, the Provincial Government of Isabela, through the Governor Faustino N. Dy Sr. Memorial Hospital, expresses its commitment to provide logistical and operational support for the mission, including hospital facilities, transportation, meals, and medical supplies, while the City Government of Ilagan aspires to facilitate patient recruitment and volunteer accommodation, and Smile Mission Ltd. endeavors to provide the necessary medical professionals, medical licenses, and funding for essential resources;

**WHEREAS**, it is necessary to formalize the commitment of the involved parties through a Memorandum of Understanding to ensure the effective and coordinated implementation of the medical mission, thereby benefiting indigent patients in the province;

**WHEREAS**, submitted for the review of this August Body is the proposed Memorandum of Understanding to be entered into by the Provincial Government of Isabela, City Government of Ilagan, Isabela, and Smile Asia, which formalizes their respective commitments for the said International Friendship Medical Mission;

**WHEREAS**, this August Body has made a careful examination of the provisions of the Memorandum of Understanding and determined that its terms are just, lawful, and consistent with the best interests of the province;

**WHEREAS**, Section 465, par. (b)(1)(vi) of the Local Government Code of 1991 empowers the Provincial Governor to represent the Province in all its business transactions and sign on its behalf all contracts and other documents upon the authority of the Sangguniang Panlalawigan;

**WHEREAS**, this August Body is unanimous in its conclusion that granting the Honorable Governor Rodolfo T. Albano with the authority to sign the Memorandum of Understanding on behalf of the Provincial Government of Isabela will advance the province's social and health goals;

**WHEREFORE**, upon motion of the Honorable Emmanuel Joselito B. Añes, duly approved and seconded in a session duly assembled, it was –
