WHEREAS, Isabela State University (ISU) is an academic institution dedicated to providing quality education, particularly through its College of Business and Management at ISU-Cauayan City Campus, which offers programs such as Tourism Management that equip students with essential knowledge and technical skills for career readiness in the tourism industry;

WHEREAS, in pursuit of this objective, the Provincial Government of Isabela, through the Isabela Tourism Office, shall implement a six (6) weeks and two (2) days or the 300-hour Skills Enhancement and Internship Program, which aims to immerse ISU students in professional environments where they can apply their academic learning, develop technical competencies, strengthen workplace ethics, and adapt to real-world industry demands;

WHEREAS, this internship program will expose students to key tourism-related functions, including event management, hospitality services, tourism marketing, research, and promotional activities, thereby complementing their academic training with hands-on experience;

WHEREAS, to ensure the effective implementation of the program, there is a need to execute an Internship Contract/Agreement between the Provincial Government of Isabela and Isabela State University - Cauayan, clearly defining the roles and responsibilities of both parties in facilitating the training, supervision, and evaluation of participating students;

WHEREAS, this partnership will be mutually beneficial, as ISU students will gain practical industry experience that enhances their career readiness, while the Provincial Government of Isabela will gain valuable assistance from interns in tourism-related programs, research, and promotional initiatives;

WHEREAS, under Section 465, (b)(1)(vi) of R.A. No. 7160, the Provincial Governor is empowered to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, this Body deems it beneficial and advantageous for the Province to grant the Provincial Governor the necessary authority to sign the Memorandum of Agreement on behalf of the Provincial Government of Isabela;

**WHEREFORE**, premises considered, upon motion of the Honorable Mary Grace D. Arreola, duly approved and seconded in a session duly assembled, it was —
