WHEREAS, it is the policy of the Provincial Government of Isabela (PGI) to foster partnerships and collaborations with educational institutions, community organization, and other stakeholders to enhance educational opportunities, share resources, and promote innovation in education;

WHEREAS, the Isabela State University – Echague Campus, is an educational institution that offers courses relevant to the industry and whose students and graduates are known for their outstanding academic skills and outstanding industry competence;

WHEREAS, the Isabela State University acknowledges the significance of practical training and industry exposure in bridging the gap between theoretical learning and real-world application, thereby ensuring that students develop the necessary skills, competencies, and work ethics required in their chosen fields;

WHEREAS, in pursuit of this objective, the implementation of six (6) weeks and two (2) days or the 300-hour Skills Enhancement and Internship Program is essential to enable Tourism Management students to gain hands-on experience, enhance their technical proficiency, and apply classroom knowledge in actual work settings;

WHEREAS, the Provincial Government of Isabela, through the Provincial Tourism Office, shall facilitate and oversee the structured training of interns, ensuring alignment with industry standards, best practices, and local tourism initiatives;

WHEREAS, to successfully implement this program, the Provincial Government of Isabela seeks to formalize its partnership with Isabela State University – Echague through a Memorandum of Agreement that will define the responsibilities and commitments of both parties in providing an effective internship experience;

WHEREAS, this collaboration will allow students to be immersed in professional environments, develop industry-relevant competencies, and acquire firsthand knowledge of the tourism sector through internship placements in PGI-affiliated offices and establishments;

WHEREAS, under Section 465, (b)(1)(vi) of R.A. No. 7160, the Provincial Governor is empowered to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, this Body deems it beneficial and advantageous for the Province to grant the Provincial Governor the necessary authority to sign the Memorandum of Agreement on behalf of the Provincial Government of Isabela;

WHEREFORE, premises considered, upon motion of the Honorable Mary Grace D. Arreola, duly approved and seconded in a session duly assembled, it was –


