WHEREAS, Our Lady of the Pillar College - Cauayan (OLPCC), a duly recognized educational institution, has expressed its intent to renew its Contract of Affiliation with the Provincial Government of Isabela to allow its Bachelor of Science in Nursing and Midwifery students to undergo clinical training in these hospitals, thereby fulfilling their academic requirements for board examination eligibility;

WHEREAS, the Contract of Affiliation outlines the responsibilities of both parties, including compliance with Department of Health policies, the designation of clinical supervisors, the assignment of student interns, and adherence to confidentiality and anti-hospital shaming policies;

WHEREAS, this agreement is aligned with the Provincial Government of Isabela's commitment to providing timely and responsive social services and strengthening the local health system through collaborations with academic institutions;

WHEREAS, Section 465, par. (b)(1)(vi) of the Local Government Code of 1991 empowers the Provincial Governor to represent the Province in all its business transactions and sign on its behalf all contracts and other documents upon the authority of the Sangguniang Panlalawigan;

WHEREAS, this August Body is unanimous in its conclusion that granting the Honorable Governor Rodolfo T. Albano with authority to sign the Contract of Affiliation on behalf of the Provincial Government of Isabela will advance the province health objectives;

WHEREFORE, upon motion of the Honorable Emmanuel Joselito B. Añes, duly approved and seconded in a session duly assembled, it was –
