A RESOLUTION DECLARING APPROPRIATION ORDINANCE NO. 2024-01 (2025 ANNUAL BUDGET) IN THE AMOUNT OF TWO HUNDRED SEVENTY SIX MILLION PESOS (P276,000,000.00) OF THE MUNICIPALITY OF CORDON, ISABELA OPERATIVE IN ITS ENTIRETY SUBJECT TO SOME CONDITIONS

WHEREAS, Appropriation Ordinance No. 2024-01, an Ordinance authorizing the Annual Budget of Cordon, Isabela for Fiscal Year 2025 in the total amount of TWO HUNDRED SEVENTY SIX MILLION PESOS (P276,000,000.00) covering the various expenditures for the operation of the Local Government for Fiscal Year 2025, and appropriating the necessary funds for the purpose pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991.

#### THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

**RESOLVED,** to declare Appropriation Ordinance No. 2024-01 (2025 Annual Budget) of the Municipality of Cordon, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of R.A No. 7160 and subject further to the following conditions:

- 1. That the grant of Medical Allowance shall be in accordance with the guidelines, rules, and regulations provided under DBM Budget Circular No. 2024-6 dated December 12, 2024;
- 2. That in accordance with LBC No. 137, dated July 13, 2021, the proper Salary Grade for the position of Agricultural Technologist shall be SG-10;
- 3. The appropriation for Donations shall be solely spent for public purposes pursuant to Sections 305 (b), 335 and 351 of the LGC;
- 4. The shares from national wealth shall be utilized for PPAs in accordance with Section 294 of RA No. 7160;
- 5. The utilization of 5% Local Disaster Risk Reduction and Management Fund (LDRRMF) and the special trust fund from the unused/unexpended balance in prior year's LDRRMF shall be in accordance with the approved LDRRM Plan and NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 as reviewed by the Office of the Civil Defense (OCD) pursuant to RA No. 10121. A copy of the OCD-reviewed LDRRMP shall be provided to this Office;
- 6. That the appropriation for the 20% Development Fund shall be subject to the pertinent provisions of DBM-DOF-DILG Joint Memorandum Circular No. 1, s. 2020 dated November 4, 2020;

That the following appropriation under the 20% Development Fund shall be identified or broken-down into specific/project component indicating the activities/programs to be undertaken and the project site/location in accordance with DILG-NEDA-DBM and DOF JMC No. 1 Series of 2016:

1. Support to Barangay Projects for P3,898,098.00

A copy of which shall be forwarded to this office

7. That all procurement activities must be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its 2016 revised Implementing Rules and Regulations. Further, the acquisition of Motor Vehicles shall be subject to the provisions of Administrative Order No. 14 dated December 10, 2018 and Budget Circular (BC) No. 2022-1 dated February 11, 2022; Res. No. 2025-07-08 Page 3 of 3

8. That the provisions for programs and projects shall be consistent with the approved Annual Investment Program (AIP) of the Municipality prepared in accordance with DILG-NEDA-DBM-DOF JMC No. 1, s. 2016 dated November 18, 2016.

**RESOLVED FURTHER**, to require the Municipality of Cordon, Isabela to comply with the herein review findings and/or conditions and notify this body of actions taken thereon.

**RESOLVED FURTHERMORE**, to furnish the Municipality of Cordon, Isabela that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

**RESOLVED FINALLY**, to send a copy of this Resolution to the **Honorable LYNN M. ZUNIEGA**, Municipal Mayor, and to the Sangguniang Bayan of the Municipality of Cordon, Isabela through the **Honorable ABEGAIL V. SABLE**, Municipal Vice-Mayor.
