WHEREAS, the KADIWA ng Pangulo "Rice for All" Program of the national government aimed to provide affordable rice options for consumers and help curb high retail prices while the P29 Rice Program is organized to determine the capability of the government to sell good quality rice at P29 per kilo to disadvantaged sectors such as indigents, senior citizens, persons with disabilities, solo parents and indigenous people;

WHEREAS, tasked to implement the KADIWA ng Pangulo "Rice for All" Program and the P29 Rice Program, the Department of Agriculture (DA) ensures the continuous availability and replenishment of affordable rice stocks in the country;

WHEREAS, for an accelerated execution and roll-out of the foregoing programs, the DA, thru the Food Terminal Incorporated (FTI), is directed to collaborate with local government units (LGUs) and position itself as a strategic partner of the government's program on food security;

WHEREAS, the FTI is a government owned and controlled corporation (GOCC) tasked to establish and operate a general market for producers, manufacturers, and farmers encompassing but not limited to the wholesale buying, selling, trading, and dealing of groceries, provisions, foodstuffs, wares, vegetables, fruits, cereals, grains, other agricultural products, meat, poultry, fish, bakery products and such other related mercantile items;

WHEREAS, it will also deploy KADIWA ng Pangulo kiosks in major public markets and sell well-milled rice purchased from the inventory of the aging stocks of the National Food Authority (NFA) and made available to disadvantaged sectors through the KADIWA centers launched by His Excellency, President Ferdinand R. Marcos Jr.;

WHEREAS, submitted for the review and approval of this August Body is the draft Memorandum of Agreement (MOA) to be executed by the PGI and the Food Terminal Incorporated. After a careful review of the MOA, this Body deems it beneficial and advantageous for the Province to grant the Governor the necessary authority to sign the Memorandum of Agreement on behalf of the Provincial Government of Isabela;

WHEREAS, under Section 465, (b) (1) (vi) of R.A. No. 7160, the Governor is empowered to represent the Province in all its transactions and sign on behalf all contracts and such other documents relative to the execution of his functions, upon authority vested upon him by the Sangguniang Panlalawigan;

WHEREAS, this Body deems it beneficial and advantageous for the Province to grant the Governor the necessary authority to sign the Memorandum of Agreement on behalf of the Provincial Government of Isabela;

**WHEREFORE**, upon motion of the Honorable Clifford R. Raspado, duly approved and seconded in a session duly assembled, it was —

RESOLVED, AS IT HEREBY RESOLVED, TO PASS A RESOLUTION AUTHORIZING THE HONORABLE GOVERNOR, RODOLFO T.
