A RESOLUTION DECLARING ORDINANCE NO. 2024-617 OF THE CITY LOCAL GOVERNMENT UNIT OF CAUAYAN CITY, ISABELA AS VALID

WHEREAS, pursuant to Article 468(a)(i) of the Local Government Code, the Sangguniang Panlalawigan has the authority to “review all ordinances approved by the sanggunian of component cities and municipalities” and to “determine whether these are within the scope of the prescribed powers of the Sanggunian”;

WHEREAS, presented before this Honorable Body is Ordinance No. 2024-617 of the City Local Government Unit of Cauayan, Isabela (CLGU Cauayan) entitled, “**ORDINANCE AUTHORIZING THE PROPOSED BORROWING OF THE CITY OF CAUAYAN, PROVINCE OF ISABELA, IN THE AMOUNT OF THREE HUNDRED MILLION PESOS (P300,000,000.00), TO FUND THE PROPOSED ROAD CONCRETING, ROAD REBLOCKING, ROAD CONSTRUCTION, PURCHASE OF SOLAR STREETLIGHTS, AND PURCHASE OF ADVANCE WASTE SOLUTION WITH POLLUTION CONTROL DEVICE (AWS-EPCD-50 UPGRADED) IN THE CITY OF CAUAYAN, ISABELA.**”;

WHEREAS, as stated in the Ordinance, CLGU Cauayan will utilize the amount of Three-Hundred Million Pesos (P300,000,000.00) from the proceeds of their Loan Agreement with the Land Bank of the Philippines to *finance the road concreting/reblocking/construction, purchase of solar streetlights, purchase of Advance Waste Solution with Pollution Control Device (AWS-EPCD-50 Upgraded) and other financial obligations relative thereto;*

WHEREAS, this Honorable Body recognizes that local government units possess direct information concerning the needs of their citizens and the conditions within their jurisdiction and thus have the appropriate standing and capacity to identify the programs, projects, and activities that will further the welfare of their people;

WHEREAS, after careful review and with due consideration to the recommendation of the Provincial Budget Office interposing no objection and stating no adverse finding to Ordinance No. 2024-617 of the CLGU Cauayan, this Honorable Body finds that the said ordinance is a valid exercise of the legislative powers of their Sanggunian and within the authority of CLGU Cauayan, as prescribed by law subject to compliance with the budgetary limitations for debt servicing as provided in Section 324 of the Local Government Code;

WHEREFORE, upon motion of the Honorable Delfinito Emmanuel L. Albano, duly approved and seconded in a session duly assembled, it was –

RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION DECLARING ORDINANCE NO. 2024-617 OF THE MUNICIPAL LOCAL GOVERNMENT UNIT OF CAUAYAN CITY, ISABELA AS VALID.
