A RESOLUTION AUTHORIZING THE HONORABLE GOVERNOR, RODOLFO T. ALBANO III, TO ENTER INTO A COMMANAGEMENT AGREEMENT, ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA, WITH THE LOCAL GOVERNMENT UNIT OF DIVILACAN, THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES – REGIONAL OFFICE NO. 2 (DENR-RO2), THE MABUWAYA FOUNDATION, INC., AND THE DIVILACAN STUDENT ADVOCATES FOR FOREST AND ENVIRONMENTAL RESILIENCY FOR THE IMPLEMENTATION AND MANAGEMENT OF THE "LANAI MARINE TURTLE SANCTUARY AND HATCHERY"

WHREAS, the Local Government Unit (LGU) of Divilacan, Isabela has proactively enacted an ordinance declaring Sitio Lanai of Barangay Bicobian and Sitio Makingaden of Barangay Dimasalansan, spanning approximately six (6) kilometers, as a Marine Turtle Nesting Sanctuary, demonstrating its commitment to environmental protection and conservation;

WHEREAS, the Province of Isabela, particularly its coastal areas, serves as an important nesting ground for various species of marine turtles, which are classified as either endangered or critically endangered under international and national conservation lists;

WHEREAS, the establishment of the sanctuary and hatchery aims to protect marine turtles from habitat destruction, illegal poaching, and other environmental threats while fostering community participation and environmental awareness among local stakeholders;

WHEREAS, the Local Government Unit (LGU) of Divilacan, in partnership with the Department of Environment and Natural Resources – Regional Office No. 2 (DENR-RO2), the Mabuwaya Foundation, Inc., and the Divilacan Student Advocates for Forest and Environmental Resiliency, has identified the need to establish and manage the "Lanai Marine Turtle Sanctuary and Hatchery" as a vital initiative for the preservation of marine turtle populations and the enhancement of local biodiversity;

WHEREAS, the Protected Area Management Board (PAMB) of the Northern Sierra Madre Natural Park (NSMNP), through Resolution No. 52, series of 2022, endorsed and adopted the Lanai Marine Turtle Nesting Sanctuary and Hatchery at Sitio Lanai, Bicobian, Divilacan, Isabela, recognizing its ecological significance;

WHEREAS, the Provincial Government of Isabela recognizes the importance of collaborative environmental initiatives and is committed to supporting projects that contribute to biodiversity conservation, environmental education, and sustainable ecotourism, ensuring both ecological protection and community engagement;

WHEREAS, a Co-Management Agreement among the PGI, the LGU of Divilacan, the DENR-RO2, the Mabuwaya Foundation, Inc., and the Divilacan Student Advocates for Forest and Environmental Resiliency is necessary for the proper implementation of the project;

WHEREAS, this agreement fosters a holistic and inclusive approach to marine turtle conservation by strengthening environmental education programs, promoting sustainable ecotourism, and encouraging collaboration among government agencies, non-governmental organizations, and local advocacy groups, thereby benefiting both marine biodiversity and local communities;

WHEREAS, under Section 465 (b) (vi) of R. A. No. 7160, the Governor is empowered to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;
