WHEREAS, the implementation of the Gawad Saka from 2020 to 2024 was postponed due to the COVID-19 pandemic, which posed significant challenges to the agricultural sector, limiting the ability to hold large gatherings and recognize outstanding farmers, fisherfolk, and agricultural workers for their invaluable contributions to food security and rural development;

WHEREAS, the Provincial Agricultural and Fishery Council (PAFC) of Isabela, through its Resolution No. 3, Series of 2024, has recommended that the Provincial Government of Isabela, through the Provincial Agriculture Office, reactivate the Annual Conduct of Gawad Saka at the Provincial Level;

WHEREAS, the agricultural sector in the Province of Isabela has gradually recovered from the disruptions caused by the COVID-19 pandemic, with farmers, fisherfolk, and agricultural workers demonstrating resilience, adaptability, and innovation in restoring productivity, ensuring food security, and sustaining economic stability;

WHEREAS, in recognition of the agricultural sector's gradual recovery and the unwavering dedication of farmers, fisherfolk, and agricultural workers, this August Body recognizes that there is a need to reactivate the Annual Gawad Saka at the provincial level;

WHEREAS, this August Body acknowledges that the reactivation of the Annual Gawad Saka at the provincial level will provide much needed recognition to our local farmers, fisherfolk and agricultural workers' outstanding contributions, inspire excellence in the agriculture sector, and reinforce the Provincial Government's commitment to advancing agricultural and fisheries development, and rural prosperity;
