WHEREAS, presented before this Honorable Body is Ordinance No. 18-2024 of the Municipal Local Government Unit of Luna, Isabela (MLGU Luna), entitled, "AN ORDINANCE AUTHORIZING THE PROPOSED BORROWING OF THE MUNICIPAL GOVERNMENT OF LUNA, ISABELA, IN THE AMOUNT OF TWENTY-FIVE MILLION PESOS (PHP25,000,000.00) TO FUND THE COMPLETION OF THE MUNICIPALITY OF LUNA 'THE MOL' MULTI-PURPOSE BUILDING (PHASE 2), TO BE LOCATED AT MIGUEL GUERRERO COMPLEX, BARANGAY MAMBABANGA, LUNA, ISABELA";

WHEREAS, the construction of "The MOL" Multipurpose Building (Phase 2) aligns with the development priorities of MLGU Luna, aiming to provide a modern, functional space that will support local governance, community engagement, and economic activities;

WHEREAS, infrastructure investments such as this project play a crucial role in driving progress, creating employment opportunities, improving government services, and fostering a conducive environment for business and social development;

WHEREAS, the proposed borrowing is a necessary financial mechanism to ensure the timely completion of the project, preventing delays that could lead to increased costs and hinder the intended benefits for the community;

WHEREAS, after thorough review and evaluation, and upon consideration of the recommendation of the Provincial Budget Office—which has raised no objections or adverse findings—this Honorable Body affirms that Ordinance No. 18-2024 constitutes a valid exercise of legislative authority and falls within the jurisdiction of MLGU Luna, subject to compliance with the budgetary limitations on debt servicing as prescribed under Section 324 of the Local Government Code;

NOW THEREFORE, upon motion of the Honorable Delfinito Emmanuel L. Albano, duly seconded and approved in a session duly assembled, it was –

RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION DECLARING ORDINANCE NO. 18-2024 OF THE MUNICIPAL LOCAL GOVERNMENT UNIT OF LUNA, ISABELA, AUTHORIZING THE PROPOSED BORROWING, AS VALID.
