WHEREAS, the Provincial Government of Isabela (PGI) is committed to supporting local farmers by expanding the Isabela Rice Assistance Program (I-RICE AP) through intensified direct palay procurement;

WHEREAS, in pursuit of this expansion, PGI has identified the need for additional warehouse facilities for proper palay storage, necessitating the purchase of five (5) parcels of commercial and agricultural land owned by Land Bank of the Philippines, with a total area of 29,040 square meters, including improvements and chattels, located in Barangay Ipil, Echague, Isabela;

WHEREAS, the properties are covered by Transfer Certificates of Title (TCT) Nos. 165-2018000676, 165-2018000677, 165-2018000678, 165-2018000679, and 165-2018000680;

WHEREAS, based on the Term Sheet dated 07 November 2024, the proposed purchase price for the said properties is Eighty-Six Million Eight Hundred Twenty-One Thousand Three Hundred Eighty-Three Pesos (Php 86,821,383.00), which will be financed through a loan agreement between PGI and the Land Bank of the Philippines-Northern Isabela Lending Center (LBP-NILC);

WHEREAS, on 26 December 2024, LBP's Special Assets Department I (SPAD I) issued a Notice of Approval formally approving PGI's offer to purchase the properties through a negotiated sale, requiring restatement, realignment, and modification of Term Loan 2 with LBP and necessitating the reallocation of funds;

WHEREAS, LBP-NILC subsequently issued a Letter of Guarantee in favor of PGI on 04 February 2025, ensuring payment of Php 86,821,383.00 through the approved loan;

WHEREAS, LBP's Special Assets Department I (SPAD I) requires, as an additional document, a Sangguniang Panlalawigan Resolution confirming, approving, and ratifying the terms and conditions of the sale, directing the Provincial Treasurer and Accountant to enter the loan in the appropriate books of PGI, appropriating the amount of the purchase price in the PGI's budget, authorizing the Bank to deduct funds as necessary for payment, and waiving the confidentiality of investment or bank deposits;

WHEREAS, to comply with the requirements set by LBP-SPAD I, this Resolution expressly authorizes, approves, and orders the execution of the following acts:

- Confirming, approving, and ratifying all the terms and conditions of the sale;
- Directing the Provincial Treasurer and Accountant to enter the loan in the appropriate books of PGI;
- Appropriating the amount of the purchase price in the PGI's budget, including other expenses, charges, and taxes, until the same is fully paid;
- Authorizing the Bank to deduct for set-off and/or deduct amounts from any
 deposits or funds of the PGI with the Bank and apply the same to the payment of
 the purchase price or only portion thereof, interests, penalties, and advances (if
 any) as may be deemed necessary by the Bank; and
- Waiving the confidentiality of investment or Bank deposits.
