WHEREAS, it is the policy of the Provincial Government of Isabela (PGI) to support and enhance agricultural and economic development through strategic partnerships and initiatives that promote sustainable livelihoods and industry growth;

WHEREAS, the Municipal Local Government Unit of Roxas, Isabela (MLGU Roxas) seeks the re-operationalization of its Livestock Auction Market to benefit livestock raisers, traders, and buyers to enhance economic activity, ensure fair trade practices, and provide a structured marketplace for the efficient sale and distribution of livestock;

WHEREAS, the Roxas Livestock Auction Market serves as a vital public facility for farmers and dealers, providing essential infrastructure such as a weighing scale, pens, corrals, tie rails, loading ramps, enclosures, and other attendant facilities to facilitate the proper receipt, weighing, identification, and sale of livestock;

WHEREAS, the re-operationalization of the said market is expected to boost economic activities, promote fair trade, and enhance the livestock industry within the province;

WHEREAS, in order to effectively collaborate and ensure the successful implementation of this initiative, it is necessary for the Provincial Government of Isabela to enter into a Memorandum of Agreement (MOA) with the MLGU Roxas

WHEREAS, submitted for the review and approval of this Honorable Body is the proposed Memorandum of Agreement between the PGI and the MLGU Roxas, providing for their respective duties and functions on the implementation of the re-operationalization of the Livestock Auction Market;

WHEREAS, under Section 465, (b) (1) (vi) of R. A. No. 7160, the Governor is empowered to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, after a careful review of the said MOA, this Body deems it beneficial and advantageous for the Province to grant the Governor the necessary authority to sign the Memorandum of Agreement on behalf of the PGI;

WHEREFORE, premises considered, upon motion of the Honorable Clifford R. Raspado, duly approved and seconded in a session duly assembled, it was –

RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION AUTHORIZING THE GOVERNOR, HONORABLE RODOLFO T ALBANO III, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE MUNICIPAL LOCAL GOVERNMENT UNIT OF ROXAS, ISABELA FOR THE RE-OPERATIONALIZATION OF LIVESTOCK AUCTION MARKET.
