ALBANO III, TO SIGN, ENTER, AND EXECUTE ON BEHALF-OF THE PROVINCIAL GOVERNMENT OF ISABELA A MEMORANDUM OF AGREEMENT WITH THE PHILIPPINE RED CROSS – ISABELA CHAPTER FOR THE PROVISION OF BLOOD PRODUCTS AND SERVICES TO CAUAYAN DISTRICT HOSPITAL

WHEREAS, the Provincial Government of Isabela and the Philippine Red Cross Isabela Chapter have a long-standing partnership, marked by mutual support and collaboration in providing Isabeleños with access to essential life-saving services, thereby protecting life and improving public health;

WHEREAS, it is the aim of the Provincial Government of Isabela to strengthen the healthcare system by ensuring a consistent and reliable supply of safe blood products for medical emergencies, surgical procedures, and other critical healthcare needs in Cauayan District Hospital;

WHEREAS, in order to achieve this objective, there is a need to execute a Memorandum of Agreement between the PGI and the Philippine Red Cross Isabela Chapter to formalize the provision of blood products and services to the Cauayan District Hospital, thereby establishing clear responsibilities and ensuring the sustainability of blood supply and related services;

WHEREAS, this partnership will improve access to life-saving transfusions, enhance the hospital's capability to respond to medical emergencies, and improve overall patient care by securing a reliable source of blood and blood components;

WHEREAS, under Section 465, (b)(1)(vi) of R.A. No. 7160 of the Local Government Code of 1991, the Governor is empowered to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, this Body deems it beneficial and advantageous for the Province to grant the Governor the necessary authority to sign the Memorandum of Agreement on behalf of the Provincial Government of Isabela;

WHEREFORE, upon motion of Honorable Emmanuel Joselito B. Añes, duly approved and seconded in a session duly assembled, it was –
