WHEREAS, it is the policy of the State to uphold the people's constitutional rights to life and property by addressing the root causes of vulnerabilities to disasters, strengthening the country's institutional capacity for disaster risk reduction and management, and building the resilience of local communities to disaster, including climate change impacts;

WHEREAS, one of the mandates of the "Provincial Disaster Risk Reduction and Management Act of 2010" is the establishment of linkage or network with other local government units (LGUs) for disaster risk reduction and emergency response purposes;

WHEREAS, forming a partnership and coordination with an LGU with a remarkable experience and training in the field of DRRM will significantly enhance another LGU's facilitation of disaster relief assistance and reduce the number of disaster victims;

WHEREAS, the Provincial Government of Isabela (PGI) is a National Gawad Kalasag Hall of Fame Awardee, known for its excellence in promoting and implementing disaster risk reduction management (DRRM), climate change adaptation and humanitarian programs that protect and shield high risk communities against extreme hazards;

WHEREAS, as a multi-awarded LGU in the field of disaster risk and management, the Provincial Government of Aurora resolved to partner with PGI for a better disaster preparedness to maximize the use of limited resources, facilitate program input/output efficiencies and increase the potential for influencing policy development;

WHEREAS, submitted for the review and approval of this August Body is the draft Memorandum of Agreement to be executed by the PGI and the Provincial Government of Aurora, to formalize the linkage relationship between the two in terms of DRRM and emergency response efforts;

WHEREAS, after a careful review of the Memorandum of Agreement, this Body deems it beneficial and advantageous for the Province to grant the Governor the necessary authority to sign the Memorandum of Agreement on behalf of the Provincial Government of Isabela;

WHEREAS, under Section 465, (b) (1) (vi) of R.A. No. 7160, the Governor is empowered to represent the Province in all its transactions and sign on behalf all contracts and such other documents relative to the execution of his functions, upon authority vested upon him by the Sangguniang Panlalawigan;

WHEREAS, this Body deems it beneficial and advantageous for the Province to grant the Provincial governor the necessary authority to sign the Memorandum of Agreement on behalf of the Provincial Government of Isabela;

WHEREFORE, upon motion of the Honorable Victor G. Dy, duly approved and seconded in a session duly assembled, it was –

RESOLVED, AS IT HEREBY RESOLVED, TO PASS A RESOLUTION AUTHORIZING THE HONORABLE GOVERNOR, RODOLFO T.
