A RESOLUTION AUTHORIZING THE HONORABLE GOVERNOR, RODOLFO T. ALBANO III, ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA, TO ENTER INTO A CONTRACT OF CONFIRMATION OF DEED OF DONATION WITH THE HEIRS OF DELFIN B. ALBANO FOR THE LAND TITLING OF THE MILAGROS ALBANO DISTRICT HOSPITAL

WHEREAS, it is the policy of the Provincial Government of Isabela (PGI) to promote and enhance public health services by ensuring that government health facilities are properly established, legally secured, and efficiently managed for the benefit of its

WHEREAS, the Milagros Albano District Hospital, a medical institution under the jurisdiction of the PGI, and is currently undergoing the process of titling of the land upon which it is erected;

WHEREAS, as a necessary requirement for the completion of the land titling process, the Provincial Government of Isabela must enter into a Contract of Confirmation of Deed of Donation with the heirs of the late Delfin B. Albano, represented by Mila T. Albano-Mamauag;

WHEREAS, the subject properties, comprising the whole portion of Lot No. 3699 with an area of 7,941 square meters, a portion of Lot No. 1915 with an area of 181 square meters, and Lot No. 3700 with an area of 70 square meters, located in Barangay Ugad, Cabagan, Isabela, were originally donated by the late Delfin B. Albano to the Provincial Government of Isabela in 1961 for the purpose of establishing a public hospital;

WHEREAS, the heirs of Delfin B. Albano have expressed their confirmation and affirmation of the said donation through a formal Contract of Confirmation of Deed of Donation, ensuring the Provincial Government's continued ownership and legal rights over the subject properties;

WHEREAS, the execution of the Contract of Confirmation of Deed of Donation is a crucial step in fulfilling the legal requirements for the land titling process, thereby securing an equivocal claim over the subject properties thereby ensuring the continuity of the operations and services of the Milagros Albano District Hospital

WHEREAS, this August Body, with deep appreciation, and gratitude acknowledges the generosity of the late Delfin B. Albano, and his heirs as well, and their commitment to supporting the Provincial Government of Isabela;

WHEREAS, submitted to this August Body is the proposed Contract of Confirmation of Deed of Donation to be entered into by the PGI and the Heirs of Delfin B. Albano, represented by Mila T. Albano-Mamauag;

WHEREAS, after careful review of the said contract, this August Body determined the same to be just, lawful, and promotive of the welfare of the Isabeleños;

WHEREAS, Section 465(b)(1)(vi) of R.A. No. 7160 empowers the Governor to represent the Province in all its transaction and sign contracts and such other documents relative to the execution of his functions, upon the authority vested in him by the Sangguniang Panlalawigan;

**NOW, THEREFORE**, upon motion of Honorable Manuel Faustino U. Dy, duly approved and seconded in a session duly assembled it was –

RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION AUTHORIZING THE HONORABLE GOVERNOR, RODOLFO T.
