WHEREAS, the Provincial Government of Isabela (PGI) recognizes the importance of providing adequate facilities and support to government agencies in the performance of their mandates, as such initiatives contribute to the efficient and effective delivery of public services, particularly in ensuring accessibility, safety, and convenience for the constituents of the province;

WHEREAS, the Land Transportation Office (LTO) – Regional Office No. 02 (LTO – R02) plays a crucial role in the enforcement of transportation laws, the regulation of motor vehicles, and the issuance of licenses and permits, making it imperative to enhance its operational capacity through the establishment of suitable facilities within the Province of Isabela;

WHEREAS, the LTO – RO2 has expressed its intent to utilize a parcel of land in Barangay Osmeña, City of Ilagan, Isabela, for the establishment, operation, and maintenance of its facilities;

WHEREAS, the PGI, as the registered owner of the said parcel of land, is willing to grant the LTO – RO2 the right to use and enjoy the property through a Deed of Usufruct, subject to terms and conditions beneficial to both parties;

WHEREAS, under Section 465, (b) (1) (vi) of R. A. No. 7160, the Governor is empowered to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, after a careful review of the said Deed of Usufruct, this Body deems it beneficial and advantageous for the Province to grant the Governor the necessary authority to sign the said deed on behalf of the PGI;

WHEREFORE, upon motion of the Honorable Clifford R. Raspado, duly approved and seconded by all members present in a session duly assembled, it was –

RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION AUTHORIZING THE HONORABLE GOVERNOR RODOLFO T. ALBANO III, TO SIGN ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA, A DEED OF USUFRUCT IN FAVOR OF THE LAND TRANSPORTATION OFFICE — REGIONAL OFFICE NO. 02, FOR THE ESTABLISHMENT, OPERATION, AND MAINTENANCE OF ITS OFFICE AND OTHER RELATED FACILITIES.
