ALBANO III, TO SIGN, ENTER, AND EXECUTE A MEMORANDUM OF AGREEMENT ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA (PGI) WITH SJ LYING-IN CLINIC FOR THE UTILIZATION OF THE PGI'S AMBULANCE SERVICES, THROUGH THE CAUAYAN DISTRICT HOSPITAL, FOR MATERNAL AND EMERGENCY HEALTHCARE RESPONSE

WHEREAS, SJ Lying-In Clinic, a duly registered private healthcare facility, provides maternal and newborn care services and may encounter emergency cases requiring immediate transport to a higher level of medical care;

WHEREAS, to ensure the immediate availability of emergency medical services and enhance the likelihood of saving lives in critical situations, there is a need to establish a structured healthcare response system that enables swift patient transfers to medical institutions capable of providing higher-level care;

WHEREAS, a partnership between the Provincial Government of Isabela and SJ Lying-In Clinic is necessary to formalize the utilization of PGI's ambulance services through the Cauayan District Hospital, ensuring efficient coordination and rapid response in maternal and emergency healthcare situations;

WHEREAS, this partnership will significantly enhance PGI's emergency response capabilities by facilitating the prompt and efficient transport of patients in critical maternal and emergency situations, thereby improving access to immediate medical care and contributing to better health outcomes for Isabeleños;

WHEREAS, under Section 465(b)(1)(vi) of R.A. No. 7160, otherwise known as the Local Government Code of 1991, the Governor is empowered to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon authorization by the Sangguniang Panlalawigan;

WHEREAS, this Body deems it beneficial and advantageous for the Province to grant the Governor the necessary authority to sign the Memorandum of Agreement on behalf of the Provincial Government of Isabela to ensure the efficient provision of ambulance services in emergency situations;

WHEREFORE, upon motion of Honorable Emmanuel Joselito B. Añes, duly seconded and approved in a session duly assembled, it was —
