**A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 05 S. 2024 (SUPPLEMENTAL BUDGET NO. 04 FY 2024) IN THE AMOUNT OF FIVE MILLION FOUR HUNDRED SEVENTY ONE THOUSAND TWO HUNDRED FORTY TWO PESOS & 92/100 (P5,471,242.92) OF THE MUNICIPALITY OF MALLIG, ISABELA OPERATIVE IN ITS ENTIRETY, SUBJECT TO CONDITIONS**

**WHEREAS**, Appropriation Ordinance No. 05 Series 2024, an Ordinance authorizing Supplemental Budget No. 04 Calendar Year 2024 involving an amount of **FIVE MILLION FOUR HUNDRED SEVENTY ONE THOUSAND TWO HUNDRED FORTY TWO PESOS & 92/100 (P5,471,242.92)** derived from the actual collection in excess of estimated Income as of November 27, 2024 and PS savings of the Municipality of Mallig, Isabela, was submitted to this Sanggunian for review, pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 05 S. 2024 (SUPPLEMENTAL BUDGET NO. 04 FY 2024) IN THE AMOUNT OF FIVE MILLION FOUR HUNDRED SEVENTY ONE THOUSAND TWO HUNDRED FORTY TWO PESOS & 92/100 (P5,471,242.92) OF THE MUNICIPALITY OF MALLIG, ISABELA OPERATIVE IN ITS ENTIRETY, SUBJECT TO CONDITIONS**

THE SANGGUNIAN PANLALAWIGAN IN SESSION DULY ASSEMBLED:

**RESOLVED**, to declare Appropriation Ordinance No. 05 S. 2024 of the Municipality of Mallig, Isabela **OPERATIVE IN ITS ENTIRETY**, subject to the posting requirements under Section 59 of Republic Act No. 7160 and subject further to the following conditions:

1. The utilization of the appropriation for Other Professional Services amounting to Ninety Five Thousand Two Hundred Pesos (P95,200.00), shall be in accordance with COA Circular No. 2015-009 dated December 1, 2015, on the Description of Accounts under the Revised Chart of Accounts for LGUs;
2. The appropriation for Donations shall be solely spent for public purposes pursuant to Sections 305 (b), 335 and 351 of the LGC;
3. That all procurement activities must be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its 2016 revised Implementing Rules and Regulations.

**RESOLVED FURTHER**, to require the Municipality of Mallig, Isabela to comply with the herein conditions.

**RESOLVED FURTHERMORE**, to inform the Municipality of Mallig, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

**RESOLVED FINALLY**, to furnish a copy of this Resolution to the **Honorable JOSE PHILIP F. CALDERON**, Municipal Mayor, and to the Sangguniang Bayan of the Municipality of Mallig, Isabela through the **Honorable DEO ANGELO ELEFANTE**, Municipal Vice-Mayor.
