WHEREAS, Ordinance No. 2024-628, an Ordinance approving Supplemental Budget No. 12 for Fiscal Year 2024 in the amount of **TWENTY SEVEN MILLION SIX HUNDRED TWENTY SEVEN THOUSAND FIVE HUNDRED THIRTY FIVE PESOS & 05/100 (P27,627,535.05)** derived from actual collection in excess of estimated income as of December 31, 2024 for various MOOE of the Mayor's Office, City of Cauayan, Isabela, was submitted to this Sanggunian for review pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991.

A RESOLUTION DECLARING ORDINANCE NO. 2024-628 (SUPPLEMENTAL BUDGET NO. 12 FY 2024) IN THE AMOUNT OF TWENTY SEVEN MILLION SIX HUNDRED TWENTY SEVEN THOUSAND FIVE HUNDRED THIRTY FIVE PESOS & 05/100 (P27,627,535.05) OF THE CITY OF CAUAYAN, ISABELA OPERATIVE IN ITS ENTIRETY SUBJECT TO CONDITIONS

THE SANGGUNIAN PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 2024-628 of the City of Cauayan, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of Republic Act No. 7160 and subject further to the following conditions:

1. The appropriation for Donations shall be solely spent for public purposes pursuant to Sections 305 (b), 335 and 351 of the LGC;
2. The utilization of the appropriation for Security Services and Environment/Sanitary Services in the amount of Two Hundred Ninety Thousand Two Hundred Nine Pesos & 64/100 (P290,209.64) and One Million Seven Hundred Twenty Four Thousand Two Hundred Fifty Pesos (P1,724,250.00) respectively, shall be in accordance with COA Circular No. 2015-009 dated December 1, 2015, the Description of Accounts under the Revised Chart of Accounts for Local Government Units;
3. That all procurement activities must be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its 2016 revised Implementing Rules and Regulations.

RESOLVED FURTHER, to require the City of Cauayan, Isabela to comply with the herein review findings/conditions.

RESOLVED FURTHERMORE, to inform the City of Cauayan, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

RESOLVED FINALLY, to furnish a copy of this Resolution to the **Honorable CAESAR S. DY JR.**, City Mayor, and to the Sangguniang Panlungsod of the City of Cauayan, Isabela through the **Honorable LEONCIO A. DALIN, JR.**, City Vice-Mayor.
