The appropriation for the grant of Collective Negotiation Agreement (CNA) Incentive in the amount of Three Million Seven Hundred Twenty Three Thousand Pesos (P3,723,000.00) shall be in accordance with DBM Budget Circular No. 2024-4, dated November 11, 2024, the Guidelines on the Grant of the Collective Negotiation Agreement (CNA) Incentive for FY 2024. Further, the account code shall be corrected to Other Personnel Benefits, 5-01-04-990 pursuant to Item 4.4.4 of the same circular.

**RESOLVED FURTHER**, to require the Municipality of Cordon, Isabela to comply with the herein review findings and/or conditions and notify this body of actions taken thereon.

**RESOLVED FURTHERMORE**, to inform the Municipality of Cordon, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

**RESOLVED FINALLY**, to furnish a copy of this Resolution to the **Honorable LYNN M. ZUNIEGA, Municipal Mayor**, and to the Sangguniang Bayan of the Municipality of Cordon, Isabela through the **Honorable ABEGAIL V. SABLE**, Municipal Vice-Mayor.
