Appropriation Ordinance No. 2024-16, an Ordinance authorizing WHEREAS, Supplemental Budget No. 3, S. of 2024, and appropriating the amount of TWENTY TWO MILLION NINE HUNDRED TWENTY SIX THOUSAND SEVEN HUNDRED PESOS (P22,926,700.00) from the un-appropriated balance of the share of the Municipality of Cabatuan, Isabela on the collection of Burley and Native Tobacco Excise Taxes for Calendar Year 2021, was submitted to this office for review, pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 2024-16 (SUPPLEMENTAL BUDGET NO. 03, S. 2024) IN THE AMOUNT OF TWENTY TWO MILLION NINE HUNDRED TWENTY SIX THOUSAND SEVEN HUNDRED PESOS (P22,926,700.00) OF THE MUNICIPALITY OF CABATUAN, ISABELA OPERATIVE IN ITS ENTIRETY SUBJECT TO SOME CONDITIONS

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 2024-16 of the Municipality of Cabatuan, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of R.A No. 7160, and subject further to the following conditions:

- 1. The utilization of the projects to be funded from the Local Government share of the Municipality of Cabatuan, Isabela in the Burley and Native Tobacco Excise Tax for the Fiscal Year 2021 amounting to Twenty Two Million Nine Hundred Twenty Six Thousand Seven Hundred Pesos (P22,926,700.00) shall adhere with the provisions of LBM No. 89, dated November 10, 2023 on the Guidelines on the release and utilization of the shares of Local Government Units (LGUs) from the FY 2021 and prior years' collection of Excise Tax on locally manufactured Virginiatype cigarettes under Republic Act (RA) No. 7171, and Burley and Native Tobacco Excise Tax Pursuant to RA No. 8240, as amended by RA No. 11346, chargeable against the allocations to Local Government Units under the FY 2023 General Appropriations Act (GAA), RA No. 11936;
- 2. The proposed project must be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its Implementing Rules and Regulations and item No. 2.3.4 of LBM No. 89 which states that:

"The programs and projects to be implemented by the beneficiary LGUs from their respective shares from tobacco excise taxes shall be in line with the policies, programs, and priorities set in the Agricultural and Fisheries Modernization Program and the Road Map for the Philippine Tobacco Industry, adopted by the DA and NTA for the period. Moreover, beneficiary LGUs are highly encouraged to allocate at least twenty-five percent (25%) of their total share for cooperative programs, livelihood projects, and financial support for registered tobacco farmers."

RESOLVED FURTHER, to require the Municipality of Cabatuan, Isabela to comply with the herein conditions and notify this body of actions taken thereon.

RESOLVED FURTHERMORE, to inform the Municipality of Cabatuan, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

RESOLVED FINALLY, to furnish a copy of this Resolution to the **Honorable CHARLTON L. UY**, Municipal Mayor, and to the Sangguniang Bayan of the Municipality of Cabatuan, Isabela through the **Honorable BENJAMIN ISABELO R. DY**, Municipal Vice-Mayor.
