THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Ordinance No. 311 s. 2024 of the Municipality of San Isidro, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of Republic Act No. 7160, and subject further to the following conditions:

- The appropriation for Donations shall be solely spent for public purposes pursuant to Sections 305 (b), 335 and 351 of the LGC. Further, the financial assistance to employees and qualified constituents of the Municipality of San Isidro, Isabela in the amount of Four Million Three Hundred Thousand Pesos (P4,300,000.00) shall be covered with appropriate guidelines and legal basis for its grant;
- 2. That the appropriation for Donations in the Supplemental AIP should fall under the MOOE column instead of PS;

RESOLVED FURTHER, to require the Municipality of San Isidro, Isabela to comply with the herein review findings and/or conditions and notify this body of actions taken thereon.

RESOLVED FURTHERMORE, to inform the Municipality of San Isidro, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

RESOLVED FINALLY, to furnish a copy of this Resolution to the Honorable **VILMER B. BRAVO**, Municipal Mayor, and to the Sangguniang Bayan of the Municipality of San Isidro, Isabela through the **Honorable LEONARDO A. TUMAMAO**, Municipal Vice-Mayor.
