WHEREAS, Ordinance No. 2024-055, an Ordinance authorizing Supplemental Budget No. 06 S. 2024 of the Municipality of Jones, Isabela involving the amount of EIGHTEEN MILLION ONE HUNDRED FIFTY THOUSAND TWO HUNDRED NINETY SIX PESOS & 90/100 (P18,150,296.90) derived from the Actual Collection in Excess of Estimated Income of the General Fund as of Nov. 30, 2024 and Waterworks as of Dec. 4, 2024, PS Savings and allowable MOOE allotments for the grant of SRI, CNA Incentive and various MOOE of the Local Government of Jones, Isabela, was submitted to this Sanggunian for review pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

NOW THEREFORE, on motion of SP Member DELFINITO EMMANUEL L. ALBANO duly seconded:

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 2024-055 of the Municipality of Jones, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of R.A No. 7160, and subject further to the following conditions:

- 1. The appropriation for the grant of Service Recognition Incentive (SRI) in the amount of Four Million Nine Hundred Thousand Pesos (P4,900,000.00) shall be in accordance with AO No. 27 dated December 12, 2024 and DBM Budget Circular No. 2024-7, dated December 16, 2024;
- The appropriation for the grant of Collective Negotiation Agreement (CNA) Incentive in the amount of One Hundred Eighty Four Thousand Four Hundred Fifty Pesos (P184,450.00) shall be in accordance with DBM Budget Circular No. 2024-4, dated November 11, 2024, the Guidelines on the Grant of the Collective Negotiation Agreement (CNA) Incentive for FY 2024;
- 3. The proper account code for Other Personnel Benefits and Fuel, Oil & Lubricants Expenses should be 5-01-04-990 and 5-02-03-090, respectively;
- 4. The appropriation for Donations shall be solely spent for public purposes pursuant to Sections 305 (b), 335 and 351 of the LGC;
- 5. The appropriations provided for "Other Maintenance and Operating Expenses" shall only be used to record expenses not falling under any of the specific maintenance and other operating expense accounts;
- 6. That all procurement activities must be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its 2016 revised Implementing Rules and Regulations.

RESOLVED FURTHER, to inform the Municipality of Jones, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

RESOLVED FINALLY, to furnish a copy of this Resolution to the **Honorable NHEL C. MONTANO**, Municipal Mayor, and to the Sangguniang Bayan of the Municipality of Jones, Isabela through the **Honorable EVELYN R. RASPADO**, Municipal Vice-Mayor.
