WHEREAS, it is a policy of the Provincial Government of Isabela to promote inclusive growth and social equity by providing sustainable livelihood and employment opportunities, especially to marginalized, displaced, and underemployed constituents, in order to improve their quality of life and foster economic resilience at the grassroots level;

WHEREAS, DOLE issued Department Order No. 239 series of 2023, to strengthen the implementation of the *Tulong Panghanapbuhay sa Ating Displaced/Disadvantaged* (TUPAD) Workers Program as part of the DOLE Integrated Livelihood and Emergency

Employment Program (DILEEP), with the objective of providing temporary wage employment for workers who are displaced, underemployed, or seasonal;

WHEREAS, the Provincial Government of Isabela (PGI), in partnership with DOLE-Regional Office 02, has successfully implemented the TUPAD Program, benefiting numerous Isabeleños by providing short-term employment opportunities and stabilizing household incomes;

WHEREAS, recognizing the continued need for livelihood assistance among disadvantaged sectors, DOLE-Regional Office II has proposed the continued implementation of the TUPAD Program in the Province of Isabela;

WHEREAS, the partnership between the Provincial Government of Isabela and DOLE-Isabela will ensure structured, transparent, and efficient delivery of temporary livelihood assistance to qualified beneficiaries, thereby addressing unemployment and underemployment, empowering disadvantaged workers, and fostering self-reliance and community development;

WHEREAS, pursuant to Section 465(b)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Provincial Governor is authorized to represent the Province in all its business transactions and sign on its behalf all contracts and documents, subject to the prior authorization of the Sangguniang Panlalawigan;

WHEREAS, this August Body deems it beneficial and in the best interest of the Province to grant the Provincial Governor the necessary authority to sign the Memorandum of Agreement on behalf of the Provincial Government of Isabela;

WHEREFORE, upon motion of Honorable Emmanuel Joselito B. Añes, duly approved and seconded in a session duly assembled, it was –
