WHEREAS, the Provincial Government of Isabela strives to enhance its healthcare initiatives by collaborating with national agencies and local hospitals to ensure the efficient provision of medical assistance to its constituents;

WHEREAS, the Medical Assistance to Indigent and Financially Incapacitated Patients (MAIFIP) Program facilitates the effective allocation of resources to local government units, thereby improving access to medical assistance for indigent and financially incapacitated patients;

WHEREAS, in order to effectively implement the MAIFIP Program, a Memorandum of Agreement (MOA) is necessary between the PGI, the DOH-CVCHD, and the MARDH to establish clear responsibilities, funding provisions, and operational guidelines for the delivery of medical assistance;

WHEREAS, submitted for the consideration of this Honorable Body is the proposed Memorandum of Agreement between the parties involved for the implementation of the said program;

WHEREAS, after a careful perusal, this Honorable Body determined that the proposed Memorandum of Agreement between the parties is just, lawful, and will improve the Isabeleño's capacity to access quality healthcare services;

WHEREAS, Section 465, par. (b)(1)(vi) of the Local Government Code empowers the Provincial Governor to represent the Province in all its business transactions and sign in its behalf all contracts and such other documents upon authority of the Sangguniang Panlalawigan;

NOW THEREFORE, upon motion of the Honorable Emmanuel Joselito B. Añes, duly seconded and unanimously approved by the members present in a session duly assembled, it was –
