WHEREAS, the Provincial Government of Isabela (PGI), in its commitment to prioritizing the welfare of local farmers, continues to pursue the development of a strategic network of safe facilities and the provision of adequate infrastructure that supports inclusive growth and sustainable rural development;

WHEREAS, the Department of Agriculture (DA), through the Philippine Rural Development Project Scale-Up (PRDP SU), has extended funding support to the Provincial Government of Isabela;

WHEREAS, the funded subproject "Rehabilitation/Improvement of Union-Barcolan Farm-to-Market Road" in the Municipality of Gamu, Isabela, falls under the Rural Infrastructure Market Linkage or Intensified Building-Up of Infrastructure and Logistics for Development (I-BUILD) component;

WHEREAS, the said project aims to enhance the efficiency and affordability of agricultural product transportation, thereby improving connectivity, mobility, and access to markets for farmers engaged in the production of rice in the said municipality;

WHEREAS, the implementation of this road development project will partially encroach on certain privately owned parcels of land, thereby affecting specific Project Affected Persons (PAPs);

WHEREAS, a formal agreement with PAPs to legally establish the terms of the affected land's use, including waivers of rights and agreements to clear and make available the concerned areas for project implementation;

WHEREAS, the Provincial Government of Isabela (PGI), through its Provincial Project Management and Implementing Unit – Technical Working Group (PPMIU-TWG), and in coordination with the concerned local government units, has conducted public consultations, identified PAPs, and prepared the necessary documents, including the draft Memorandum of Agreement (MOA), to facilitate the smooth implementation of the project;

WHEREAS, after careful review, this August Body has determined that granting the Honorable Governor the authority to represent the Provincial Government of Isabela in entering into the said agreement with PAPs is in the best interest of the Isabeleños and will further the Province's agricultural objectives;

WHEREAS, Section 465(b)(1)(vi) of R.A. No. 7160 empowers the Provincial Governor to represent the Province in all its transactions and to sign on its behalf all contracts and other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREFORE, upon motion of the Honorable Clifford R. Raspado, duly approved and seconded in a session duly assembled, it was –

RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION AUTHORIZING THE HONORABLE GOVERNOR, RODOLFO T.
