RESOLUTION RECOMMENDING THE AWARD OF CONTRACT TO NAGKAISANG MAGSASAKA NG ISABELA AGRICULTURE COOPERATIVE WITH PR NO. 100-2025-02-0095 AMOUNTING \$\interprecep=64,900.00\$ THROUGH NEGOTIATED PROCUREMENT UNDER COMMUNITY PARTICIPATION OF SECTION 35.11 OF THE REVISED IRR OF R.A 12009 FOR THE PROCUREMENT OF RICE AS FOOD ASSISTANCE TO PNP MANEUVER COMPANY USE

**WHEREAS**, Section 11 of R.A. 11321 or the "Sagip Saka Act" enacted on April 17, 2017, requires National and Local Government Agencies to promote and support farmers and fisher folk enterprises development by directly purchasing agricultural and fishery products from accredited farmers and fisher folk cooperatives and enterprises;

**WHEREAS**, Section 11 of R.A. 11321, 2<sup>nd</sup> paragraph, provides that the procurement by national and local government agencies of said agricultural and fishery products shall be exempt from the application of the bidding process prescribed under relevant government procurement laws, provided, that said agencies shall undergo a negotiated procurement under the applicable guidelines of the GPPB;

WHEREAS, The GPPB issued the Implementing Rules and Regulations of Republic Act No. 12009 or the New Government Procurement Act effective February 25, 2025;

WHEREAS, Section 35.11 of the IRR of R.A 12009 provides that The Procuring Entity may directly purchase Goods, including agricultural and fishery products from local farmers and fisherfolk, and directly negotiate simple Infrastructure Projects with local communities or social groups (CSG) or members thereof, subject to the guidelines to be issued by the GPPB;

WHEREAS, based on prior consultation with the local community, and in the interest of the sustainability of its food assistance program, the Provincial Government of Isabela has deemed it desirable to call for the participation of the local community for the procurement of RICE AS FOOD ASSISTANCE TO PNP MANEUVER COMPANY USE;

WHEREAS, the Provincial Government of Isabela, has previously conducted market scoping and has determined the availability of CSG within its jurisdiction capable of supplying the required Goods for said program;

WHEREAS, NAGKAISANG MAGSASAKA NG ISABELA AGRICULTURE COOPERATIVE is classified as Organized CSG pursuant to Section 35.11;

WHEREAS, the BAC has validated, with due diligence, that the technical, legal and financial capabilities of NAGKAISANG MAGSASAKA NG ISABELA AGRICULTURE COOPERATIVE to supply and deliver the items to be procured;

WHEDEAS upon confirmation of such canabilities and after due deliberation of the
