## RESOLUTION NO. 2610-GS-038-A Series of 2020

RESOLUTION RECOMMENDING TO THE PROVINCIAL GOVERNMENT OF ISABELA, REPRESENTED BY THE GOVERNOR, HON. RODOLFO T. ALBANO, III, THE NEGOTIATED PROCUREMENT OF MEALS AND LODGING TO BE AWARDED AT PUNTA AMELITA RESORT FOR COVID-19 FRONTLINERS USE

WHEREAS, on March 9, 2020, the President signed Proclamation No. 922 declaring a State of Public Health Emergency throughout the Philippines upon the recommendation of the DOH following the confirmed local transmission of the novel coronavirus disease (COVID-19);

**WHEREAS**, to address the concern for the declaration of State of Public Health Emergency, a Resolution No. 2020-09-4 was enacted by Sangguniang Panlalawigan declaring the whole Province of Isabela under state of calamity due to the spread of African Swine Fever and 2019 Corona Virus Disease;

WHEREAS, to effect responsive, accessible, comprehensive, efficient and immediate response to provide the needs of our constituents in relation to Corona Virus disease known as Covid-19;

**WHEREAS**, Rule XVI Section 53.2 of R.A 9184, otherwise known as the Government Procurement Reform Act, provides for Negotiated Procurement as an Alternative Method of Procurement of Goods;

WHEREAS, upon review of the urgency to procure, where negotiated procurement under emergency cases may be resorted to, in case of imminent danger to life or property during a state calamity, the committee recommends to procure through the Negotiated Method;

NOW, THEREFORE, THE BIDS AND AWARDS COMMITTEE RESOLVES AS IT HEREBY RESOLVED TO RECOMMEND TO THE PROVINCIAL GOVERNMENT OF ISABELA, REPRESENTED BY THE GOVERNOR, HON. RODOLFO T. ALBANO, III, THE NEGOTIATED PROCUREMENT OF MEALS AND LODGING TO BE AWARDED AT PUNTA AMELITA RESORT FOR COVID-19 FRONTLINERS USE THROUGH NEGOTIATED METHOD PURSUANT TO AND IN ACCORDANCE WITH SECTION 53 OF R.A. 9184;
